Ride and Stride | Our grants

The September 12 2009 Ride and Stride raised £26,169, with an additional £4.200 recoverable in Gift Aid. The Trust and the churches chosen by the participants will receive half each. This total was slightly lower than in 2008 and more worryingly, the lowest since 1998. But many thanks to all who participated and particularly to CHCT Trustee Canon Chris Barber who raised £890, and the Revd John Graham (better known as Araucaria, compiler of Guardian crosswords), who raised the extraordinary sum of £1,542.


With the loss of the WREN grant, we are especially keen to increase our income from the day and want to make the 2010 Ride and Stride as successful as we possibly can. We will be helped by the National Churches Trust who will be promoting the event nationally (see www.rideandstrideuk.org) but we need your help too! In just two hours, you could walk around ten churches and college chapels in Cambridge or cycle to the same number in the countryside. And you know it does you good!

We need a new County Organiser and some new deanery organisers too. The latter distribute the information around their area and answer any queries (or pass them on to the County Organiser), so are at their busiest in May and around the day of the Ride. You don't need to ride yourself, see the time you give as your contribution!

A new County Organiser will be the key to our success this year and could also contribute as a member of the Executive Committee, so if anyone wants to make this valuable contribution to the Trust (and so to the churches of Cambridgeshire), please contact the Chairman at 01353 645131.

The full list of grants and loans made in 2008/09 appeared in the annual Report, but the 'pie-charts' below show how much we have depended on the WREN block grant to help Cambridgeshire churches.

Trust money has been concentrated on making loans to 17 places of worship, often in addition to grants. We believe a loan is an incentive to get the works underway; wallets can open when a scaffold goes up as donors can see the project has actually started.

From the Chairman

The Trust offers grants and loans to places of worship from money we raise ourselves and from funding derived from the Landfill Communities Fund by Waste Recycling Environmental Ltd (WREN). Last year's Newsletter warned that the latter was likely to diminish as the nation increased its efforts to recycle rubbish. However, the Trust was taken aback to learn in November that WREN would no longer be awarding us a block grant to distribute to Cambridgeshire churches on their behalf. WREN's decision follows concern about its ability to met the landfill tax regulations when grants are offered by a third party like CHCT.

In effect, our available funding for grants has more than halved. In each of the last four years, we have given an average of £56300 in grants, equally split between WREN and CHCT. In addition, WREN has given us awards from their Gift-aid fund totalling nearly £34000 since 2006. We are told 'WREN would still like to be able to support Churches and we are looking for ways of being able to provide funding under a new program (sic)...but it is unlikely there will be any firm news before June 2010'. Trustees expect to have awarded the entire WREN monies by June, so we have decided to use all last year's income for CHCT grants in 2010/11 (rather than increase the money for loans). Most of our annual income comes from the annual Ride and Stride event in September and so we will be putting extra effort into it this year (see page 4).

We have also looked hard at our own expenses in running CHCT and concluded that we are no longer covering basic running costs – the Annual Report, this newsletter, Ride and Stride, website - from our continued on page 2

The trust is an independent Charity with a primary task to support the repair and restoration of places of Christian worship in Cambridgeshire. Its funds accrue from the annual sponsored cycle ride and are used to make grants and interest-free loans to churches. It also gives grants from Landfill Tax Credits made available through Waste Recycling Environmental Ltd (WREN).

Support to the Trust is also given through Membership. Members receive advance notices of the Annual Conference and the summer afternoon Church Tours. Annual subscription is £10.

subscriptions. This is not so surprising, as we believe it is at least twenty years since the present £10 minimum annual subscription was set! After comparing CHCT with other county church trusts, Trustees now wish to raise the annual member subscription to £20. We have decided not to introduce a 'couples' rate with its increased bureaucracy, but will continue to offer a reduced fee for the annual conference to each member and a guest. These new rates will be presented to the AGM for introduction from January 2011.

Unlike some other trusts, our programme of church tours will remain free, as we wish to encourage as many people to come as possible (but we will try to recruit new members.) The congregational subscription will also be raised to £50 and we will expect grant and loan recipients to take out a congregational subscription for up to four years, so contributing to our funds for the benefit of others.

This increase in subscriptions entails a major overhaul of our membership list and we are taking the brave step to computerise it! We will also introduce a standard 1st January renewal date from January 2011 and forms for payment at the new rate will be distributed with the papers for the Annual General Meeting to be held in October 2010. Members who are due to pay an annual subscription between 1st July and 31st December this year will be credited with half the new annual subscription.

These changes should make the Trust easier and cheaper to run and once set up, enable your hard working Executive to concentrate on our real business, raising and distributing funds for the repair and enhancement of the historic places of worship in Cambridgeshire. Thank you to all our members for your support over the last year and and our special thanks to Archdeacon Hugh McCurdy, who has donated £1,000 raised from his sponsored cycle ride last year to all the churches in his archdeaconry. Thank you, Hugh.

Peter Hewitt – An immense contribution

The sudden death of Peter Hewitt, our tireless membership secretary, greatly saddened us all. Trustees who attended his memorial service in his beloved St Wendreda's Church in March were astounded to discover just how many other activities Peter was involved with however did he find the time for CHCT? His contribution was immense and we were very touched that he remembered us in his will; his legacy will be commemorated by a grant in his name.

Moving on and moving in

We wish Rt Revd Anthony Russell and his wife Sheila a long and happy retirement in Oxfordshire. Their strong support for CHCT during his ten years as Bishop of Ely is very much appreciated.

Trustees welcomed Rt Revd Dr David Thomson, Bishop of Huntingdon, as a new CHCT Trustee in January. His diocesan knowledge will be invaluable in guiding our work, but Bishop David is also a scholar of mediaeval art and architecture and so we look forward to benefiting from his academic contributions too.

Congratulations to our founding Trustee Julian Limentani for being made a lay canon of Peterborough Cathedral (where he is the Chapter's architect) and the award of a Papal Medal for his architectural services to the Diocese of East Anglia, both in 2009.

Today's Cambridgeshire includes the former Soke of Peterborough, now a unitary authority. The southern part is in the Church of England diocese of Ely, the northern in the diocese of Peterborough. We therefore look forward to welcoming Ven. Donald Allister when he is installed as the new Bishop of Peterborough after Easter.

Protecting metal roofs

2009 has brought some respite from the spate of thefts from metal roofs, though there appears to be a rising trend now (possibly due to the longer winter nights).

Insurance companies, especially EIG (see www.ecclesiastical.com) encourage preventative measures and there is a great deal of practical advice available from them and from

CHCT will offer 50% of the cost of applying Smartwater to a maximum grant of £1000. Using it should at least double the amount of your cover in the event of a theft to £5000 (which is actually close to the average claim value). CHCT is extending its offer to the cost of installing an alarm or CCTV system that meets the approval of your insurers. These are not as expensive as you might think, especially if they can be mounted in the tower overlooking hidden roofs; monitoring and links do need careful thought though. Ask your insurer or architect for advice on what is available and appropriate for you - and don't rely on a salesman's patter!
